

### **Bobbins Before School Club...now with breakfast!**

I would like to inform you of some changes which will take effect from January for Bobbins Before school club. From the new term, Mrs Baker and Mrs Smith will be leading the club together. Many of you know Mrs Baker and Mrs Smith from their work in school already. Two adults will now run Bobbins due to increased regular demand from parents for this service.

From Tuesday January 6<sup>th</sup>, when the children return from their break, Bobbins before school club will be called 'Bobbins Breakfast Club' as breakfast will then be offered as part of this service. Due to two adults now working in Bobbins and breakfast being provided, the pricing structure has been revised. These prices are the same as those in other local schools which provide the same service. I would also emphasise that school makes no profit from this service, and run it entirely as a service provided by us, for working parents. From January 6<sup>th</sup>:

- Children dropped off at 8.00am: £3.50 (includes breakfast): Children must arrive by 8.15, when breakfast will be served.
- Children dropped off at 8.00am: £3.00 (not including breakfast)
- Children dropped off at 8.20am: £2.50 (breakfast not included)
- Should a second child (i.e. a sibling) be also included, a 50p 'discount' will reduce the cost to parents E.g. £3.00 for breakfast
- Cereal and toast will form the basis of the breakfast on offer.
- Payments will be expected to be made, along with a completed booking form handed in to the school office or to Bobbins staff, by the *Thursday preceding the week of the booking*. This is to ensure all monies are up to date and stock for breakfast can be ordered in sufficient time.
- The weekly booking form has been revised to reflect these changes. These are now available from Bobbins staff and our school website.

I feel the service on offer for the cost is a fair one and provides the flexibility that parents seek for childcare in the morning.

### **Free School Meals... are you entitled?**

If you think your child may be entitled to free school meals, please let us know. Mrs Birch, in the office can provide you with any information you need. As with all personal family matters such as this, the strictest confidence is adhered to at all times. Government guidance on entitlement is below.

#### **To apply a child's parent(s) should be in receipt of one of the following benefits or credits;**

Income Support; Income-Based Jobseeker's Allowance; Income-Related Employment and Support Allowance; Child Tax Credit, provided you are not entitled to Working Tax Credit, and have an annual household income (as assessed by HM Revenue & Customs) that does not exceed £16,190; Support under part VI of the Immigration and Asylum Act 1999 or Guarantee element of State Pension Credit.

Where parent(s) are entitled to Working Tax Credit during a four-week 'run-on' period after they stop qualifying for Working Tax Credit, their children are entitled to free school meals. Children who receive Income Support or Income Based Jobseekers Allowance in their own right are also entitled to Free School Meals.
